

Terrorism is one of the forms of political violence and an important challenge and a threat to countries and the international community.

Terrorism is difficult to separate observed in relation to one region or country because compared characters in terms of method. However, in addition, terrorism is not the same everywhere and it can be generally spoken about. Thus, for example, one form of terrorism based on the consistent ideological program that is based on the fact that the individual terror and political murder may topple or seriously shaken the political order or system. The second, derived from national liberation struggle and beliefs that this fight will be perform better if it is to support terrorism, third, encourage religious fanaticism and similar. However, undoubtedly is tho the terrorism fall's and falls very different social and political forces, groups and organizations, and that they had different reasons and goals.

"One of the main reasons that terrorism has become so widespread in the modern international system that it was cheap, lower risks , potentially very useful method of fighting for all groups and regimes." Stresses P. Wilkinson.

However, Ž. Bodrijar (J. Baudrillard) believes that terrorism is symbolic violence, and to the spirit of terrorism is reflected in the fact that you should never attack force which is approximately the same ratio of forces.

"Beware of hatred, don't wrong to themselves and to the people"

In the European area is terrorism occur as a tool of the minority that felt that it affects some interest and that is, in my own fear for the preservation of the interests, the position of cause fear in the real or imaginary enemies.

Thus, except in developed countries (England, France, Spain, Greece), terrorism became a problem of the periphery and half areas, which specifically refers to the region of Balkan .Namely, expressed the importance of Security unstable this region, especially due to attempts to solve national and territorial issues.

Namely, the trend of ethnic and ethnic-religious conflict continues, because "99 percent of the major armed conflicts in the world lead in the state, in the background most of them is ethnic or religious conflict."

According to the request for the implementation of the investigation, for the preparation of terrorist actions are suspect: VP, live in Detroit, Lj. D Drešaj from the village of Tuzi, American citizens, while in the run adds Z. Ljuca from Detroit and Sole Đ. Ljucović from the village of Kochi. In custody is not only Koljčević, which I reported Bašoviću judge, after a hearing was put to defend himself from freedom. The request for the implementation of the investigation states that the Albanian out foreign citizens in Detroit financed movement for regionalization of the Albanian minority in Montenegro, and that is the word of the organizations that are funded UČK in Kosovo. According to these allegations, 10 September was planned that some members of UČK and enter the territory of Montenegro and to carry out terrorist actions in Tuzima and Malesiji. The police action "Eagle's Flight" confiscated a large quantity of weapons, long and short pipes, rocket launchers "wasp", hand grenades and antitank mines.

Podgorica - Higher Court in Podgorica sentenced yesterday twelve defendants for conspiracy and preparation of terrorist actions in Montenegro in 47 years and seven months in prison. Five accused of holding unauthorized weapons convicted a total of two years and four months in prison. Verdict yesterday phrase criminal Council which is chaired Judge Ivica Stankovic.

Added Z. Ljucaj (57), citizen of the United States, for the criminal offense of conspiracy and preparation of terrorism is condemned in a single sentence of six and a half years, Đ. D (33) and V P. S (44) by five, and P. S (49) in six, Z K. B (47) and S Lj. I (54), citizen of the United States am four, a DJ Lj. I (44) and V Lj. D (39) by two years and five months in prison. Đ Đ. LJ (36), who is in hiding, sentenced to three years and three months in prison, while P M. D (40), and the citizens of the United States R Đ. D (49) and K T. D (60) in the three years in prison.


The court after the verdict extended detention D Lj, and determine custody Đ Lj, who is in hiding. Other accused abolished the custody and guard the freedom. The reasoning judgments judge Stankovic said that the court concluded that the accused made a criminal offense based on the log Anton Siništaja, his statements from criminal before proceedings, on the basis of reports on the crossing of state borders and finding weapons. Anton Siništaj is at the trial claimed that the diary writing. - Not accepted the allegations in the indictment to which the word is about organized crime, because the indictment omitted modified states that the criminal offense to make a profit gain and power, which is the condition for the existence of the criminal acts of organized crime. The defendants were aware of their actions and wanted its execution, and there is awareness of the accused to act as confederate. Defendant Dodi Ljucaju extended detention because of the risk of flight, because the arrest in Austria - Stanković said the judge in the reasoning judgments.

They are supposed to provide support and assistance using the weapons and explosive, that they obtain and keep hidden and begin "national war of national unification" in the goal - the creation of territorial region inhabited by Albanian population in Montenegro, with a special status of the opposite Constitutional Organization of Montenegro - is one of the key points of the indictment
